Jan. 23rd 1953. A Parish Meeting was held in the Day School Room
on the evening of Jan. 23rd 1953 at 7-15 pm. due
notice having been posted on the Church & Chapel
notice boards and in the Post office. Notices
were also posted in the two licensed houses in the
Village The Bell and The Mule Horse.

S. J. Proctor, P. Armsby, B. Armsby, & J. Armsby,
S. Clarke, Tom Rix & H. Rix.
Minutes of the last meeting were read and
approved being then signed by the Chairman.
 arising out of these minutes the Chairman said
that the sum of £10 had been subscribed by
the house to house collection for the King
George VI Memorial Fund and £2 from the
Church Collection, making a total of £12.
The Chairman had learnt from Mr. P. Warner

that a collection for this Fund had previously been taken at a Sunday Chapel Service and forwarded to the King George VI Memorial Fund. Receipts for £10 and £2 were received by the Chairman from Mr. A.B. Morrison, Treasurer of the Fund at the Donham Rural District Council Offices where a record received from each parish will be kept. The receipt for the Church Collection was handed to Mr. R.G. Robinson.

A general discussion then followed as to the various forms of entertainment which should take place in the Village on Coronation Day and a decision was reached that this would depend on how much money was available. The present balance of £17 of parish funds was considered insufficient to spend on these celebrations and it was therefore proposed by Mr. S.J. Proctor and seconded by Mr. W. Miller that a house to house collection be made to raise a Coronation Fund. The Chairman said that he would be pleased to do this with the help of Mr. Tom Rix on the same lines as the King George VI Memorial Fund Collection. The Chairman then said he would ask Mr. Stephenson of Stoke Ferry if he would be so good as to give one of his film shows in the Village at which there would be a Silver Collection and the proceeds would go to the Coronation Fund.

The subject of Coronation Cups for the children, as a commemoration of the day, was then raised and after the Chairman had promised to obtain a sample cup for the approval of the Meeting, Mr. R.G. Robinson

said that he would be very pleased to present these cups as a gift to all the children & school children of the village. A vote of thanks was then proposed to Mr. Robinson by the Chairman and seconded by Mr. W. Miller.

After this various propositions were put forward as suggestions for functions to be held on Coronation Day, they included teas for the children, gifts voted for the old, fireworks, the planting of trees as a permanent village commemoration or a seat to be placed by the pond. The Chairman promised to see Mr. A.B. Harrison and the Food Office with regard to allowances for children and extra rations to be applied for in the event of teas.

With regard to the above propositions it was felt that further discussion would take place at some future meeting after more consideration had been given to them.

It was agreed that the next meeting should be held on Friday evening Feb: 13th. 1953
at 7.15 pm.

After this the Chairman declared the meeting closed.

Feb: 13th 1953.

A Parish Meeting was held in connection with the Coronation Celebrations in the School Room on Friday evening Feb: 13th. at 7-15 pm. due notice having been given on the Church & Chapel notice boards and in the Post office and other public premises. Parishioners present were:

Mrs. R. Proctor, Mrs. R. Miller, Mrs. B. Armsley, Mrs. F. Savage, Mrs. C. Payne and Messrs. T. Rix, Bert Armsley, J. Armsley, W. J. & R. Miller, Ralph Proctor & S. J. Proctor, P. Warner, C. Payne, F. Savage, Tim Rix, Herb. Rix & Ches. Rix, W. Sherwood & E. Carter. Mr. C. M. Ingham

was in the Chair. The minutes of the last meeting were read, approved, and signed by the Chairman. Arising out of these minutes it was proposed by Mrs. Armsley and seconded by Mr. T. Rix that Mr. P. Warner be appointed Treasurer for the Coronation Fund which now totals £55-3-3 being subscribed by house to house collection, files show in the Chapel school rooms and raffle for a cocked kindly presented by Mr. Anth. Rix.

A letter was then read by the Chairman from the Downham Rural District Council regarding an appeal to be made in the village for the Norfolk Flood Relief Fund. After some discussion it was agreed to organise another house to house collection and the proceeds to be forwarded to Mr. A. B. Harrison, clerk to the Council.

Discussion was then resumed on the Coronation Day functions and two committees were appointed for entertainments and sports. Mrs. R. Proctor and Mrs. R. Miller were

proposed and seconded for organising any entertainments during the day and evening and Mr. R. Proctor and Mr. R. Miller were proposed and seconded as forming a Sports Committee to run in conjunction with Miss Stanbury's School sports.

The Chairman then suggested that, as a rough guide, the allocation of money to the various committees from the Fund might be £20 to the Tea Committee, £15 for Sports Committee (including gifts for the old people and the cost of the trees) and £10 to the Dance Committee. More suggestions were made regarding events at the Sports and it was suggested that a Fancy Dress Parade be organised for the children, also that an insurance policy be taken out to cover the Sports Meeting and other events during the day. After this the Chairman declared the Meeting closed.

A Parish Meeting was held in connection with the Coronation Celebrations in the School Room on Friday evening Apr: 24th 1953 at 7-30 pm. due notices having been posted. Parishioners and members of the various committees present were: Mrs. R. Proctor, Mrs. R. Miller, Mrs. F. Savage and Miss Stanbury & Messrs. R. G. Robinson, P. Warner, W. R. Miller, S. Proctor, ~~and~~ C. Rix and T. Rix. Mr. C. W. Ingham was in the chair. The minutes of the last meeting were read, approved and signed by the Chairman. Arising out of these minutes the Chairman

then said that the Coronation Fund amounting to £55-3-3 was now in the hands of the Treasurer, Mr. P. Warner, and all applications for cash expenditure should be made to him on behalf of the Coronation Celebrations. With regard to the Norfolk Flood Relief Fund a sum of £40 had been collected and paid into Mr. A.B. Harrison, clerk to the Downham Rural District Council, and for which a receipt was now held. Notice of the amount ^{collected} had appeared in the 29th list in the Eastern Daily Press.

It was then suggested by Mr. R. Miller that the catering for the Coronation Day celebrations be undertaken by a catering establishment. After some discussion the Chairman put this matter to the vote by a show of hands and it was agreed that Mr. Miller should ask Mr. Shane of the Bull Hotel, Stoke Ferry, at what price he was prepared to undertake the catering for 150 people.

After this some discussion took place among the committees regarding the events to take place on the Coronation Day as regards sports ^{in the afternoon} and entertainment in the evening. Mrs. B. Levine and Mrs. J. Ingham would be asked to judge the Children's Fancy Dress Parade. It was agreed that the next meeting would be called for May 8th.

The chairman then declared the meeting closed.

Discussions then took place between the committees with regard to sports and Entertainment and the amount of money which could be allotted for the various functions.

It was agreed that the next and final meeting should be held on May 27th at 7.30.

The chairman then declared the meeting closed.

1953. CORONATION DAY.

" A United Service was held in the village Church of All Saints at 9.30 in the morning, the Rev. G. E. Childs officiating. The next event was to be the parade of the children in fancy dress and afterwards the judging at 2.30 in the afternoon. During to the very bad weather conditions prevailing throughout the day this event was held in the School Rooms.

Succeeding this event the children were then taken for a ride round the countryside in cars very kindly lent for the occasion

During the evening a Social was held in the School Rooms where dancing and games took place. Special mention might be made here of the excellent work done during this Social by Mrs. Ralph Proctor and Mrs. Bob Miller which contributed so much in making the evening such a success.

During to the very bad weather conditions the "Children's Sports in the afternoon and Sports for the Coronation in the early evening were cancelled."

Programme sheets showing the times for the different events throughout the day were printed and distributed to every household.
